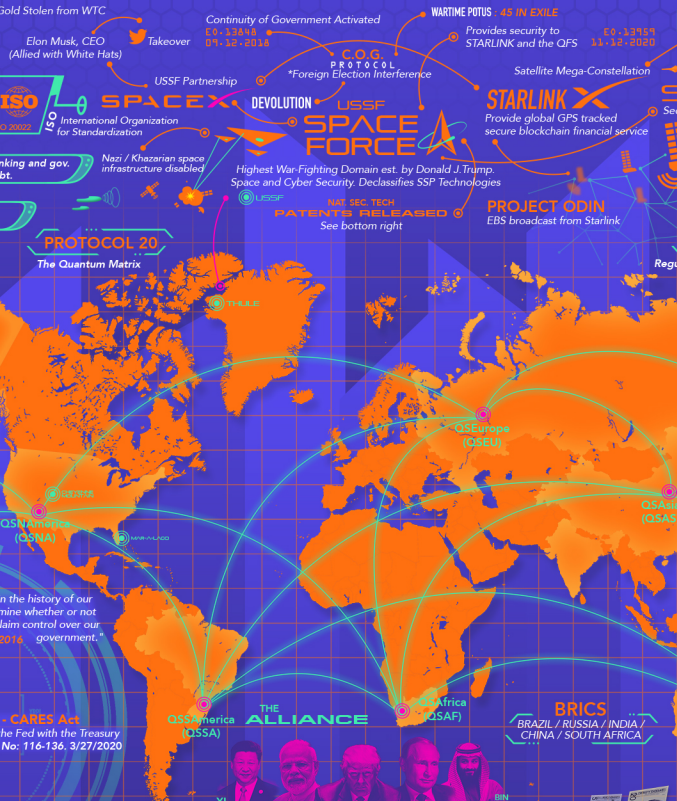

ARTICLES OF NESARA & GESARA:

- I. Abolishes Income Tax. Repeals the 1913 Sixteenth Amendment.
- II. Abolishes the IRS. Employees of the IRS will be transferred into the US Treasury national sales tax area.
- III. 17% flat rate non-essential new items only sales tax revenue for the government. Food and medicine will not be taxed, nor will used items such as old homes.
- IV. Increases benefits to senior citizens. Tesla Med-Bed Technology introduced.
- V. Returns Constitutional Law to all courts and legal matters.
- VI. Reinstates the Title of Nobility Constitutional amendment. "Thirteenth Amendment"
- VII. Establishes new political Elections within 120 days of NESARA's announcement. Interim government will cancel all National Emergencies & return constitutional law.
- VIII. Monitors elections and prevents illegal election activities of special interest groups.
- IX. Creates a new U.S. Treasury rainbow currency backed by gold, silver, and platinum precious metals, ending the bankruptcy of the United States initiated by Roosevelt, 1933.
- X. Forbids the sale of American birth certificate records as chattel property bonds by the US Department of Transportation.
- XI. Initiates new U.S. Treasury Bank System in alignment with Constitutional Law.
- XII. Eliminates the Federal Reserve System. Instates Transition period: Federal Reserve shall operate under the U.S. Treasury for one year while all fiat notes are removed from the money supply.
- XIII. Restores financial privacy. Personal banking with Private Keys and quantum resistant algorithms.
- XIV. Retrans all judges and attorneys in Constitutional law.
- XV. Ceases all aggressive U.S. government military actions worldwide.

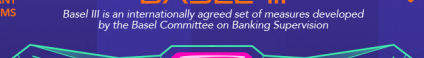
