My name is Ana and I have an 11 year old boy named Gabriel who I have been trying to save from the pedophile network his father belongs to in Belgium.

When he was about to turn 6 years old my son began telling me about sexual abuse from his father, who I'm long-separated from. That is the moment I started my desperate attempt to find ways to save my child.

I went to an incest help association in Brussels. I meticulously recorded everything. I saw a specialized lawyer. I tried to work through the court system. I began petitioning for help from abroad. At every turn I understood that it would be far from easy because of all that was against me. The Father has had much power so I was ridiculed and maligned everywhere from my son's school to the courts.

My son then started to offer many more details of what he was experiencing, for example he would talk about men dressed in black hoods coming to his father's home. The amount of suffering my boy was going through was devastating. Unbearable.

The more I found out through the years about the ritual abuse, the more targeted I became. Anybody who dared to help me was also targeted. My son's father had power and influence over every area of life. He has status in the local pedophile network. He has long standing connections of power through his extended family in Belgium and in Italy. He is an executive in the pharmaceutical business and worked almost 20 year for Johnson & Johnson.

Even with all we've been through and endured over the years, I still become more and more shocked by the extension of the network's gripping influence through all the layers of society.

There is no possibility of calling the police for help, I had occasions where it became clear they work with him. The use of doctors, dentists, psychologists, school officials is a daily affront. **People follow me to terrorise me,** sometimes letting me see the weapons they carry. door and call my phone at all hours. I could go on and on. In every imaginable way there are constant attempts to drive me into the depths of desperation.

When my son was only 7 years old he was tortured extensively. While this was happening his father took me to court to ensure I remained powerless. The consequences that the corrupted courts imposed on me then and throughout the years include:

- Forced participation with Father-chosen court-backed psychologist
- Public ridicule of me based on lies and slander
- Harsh admonishment by judges
- Betrayal by my own lawyers

This report is a small portion of what we have lived through. My story is extensive. - **The name of this Update** has always been Restored Republic via a GCR.
- **In 1865 the Q movement was started by some Military Generals upon the assassination of President Lincoln on 15 April 1865.** The Republic for the United States of America was the actual de jure government that our founding fathers gave

- **JFK Assassination: Cronkite Informs a Shocked Nation On June 4, 1963,** a virtually unknown Presidential decree, Executive Order 11110, was signed with the authority to basically strip the Rothschild Bank of its power to loan money to the United States Federal Government at interest. With the stroke of a pen, President Kennedy declared that the privately owned Rothschild Federal Reserve Bank would soon be out of business.
- **The Christian Law Fellowship has exhaustively researched this matter through the Federal Register and Library of Congress.** We can now safely conclude that this Executive Order has never been repealed, amended, or superceded by any subsequent Executive Order. In simple terms, it is still valid.
- **When President John Fitzgerald Kennedy signed this Order,** it returned to the United States federal government, specifically the Treasury Department, the Constitutional

power to create and issue currency – money – without going through the privately owned Rothschild Federal Reserve Bank.

- **The Federal Reserve:** A myth that all Americans live with is the charade known as the “Federal Reserve.” It comes as a shock to many to discover that it is not an agency of the United States Government. The name “Federal Reserve Bank” was designed to deceive, and it still does. It is not federal, nor is it owned by the government. It is privately owned. It pays its own postage like any other corporation. Its employees are not in civil service. Its physical property is held under private deeds, and is subject to local taxation. Government property, as you know, is not.
- **It is an engine that has created private wealth that is unimaginable,** even to the most financially sophisticated. It has enabled an imperial elite to manipulate our economy for its own agenda and enlisted the government itself as its enforcer. It controls the times, dictates business, affects our homes and practically everything in which we are interested.
- **It takes powerful force to maintain an empire,** and this one is no different. The concerns of the leadership of the “**Federal Reserve**” and its secretive international benefactors appear to go well beyond currency and interest rates.
- **Executive Order 11,110:** President Kennedy’s Executive Order 11,110 gave the Treasury Department the explicit authority: “to issue silver certificates against any silver bullion, silver, or standard silver dollars in the Treasury.” This means that for every ounce of silver in the U.S. Treasury’s vault, the government could introduce new money into circulation based on the silver bullion physically held there. As a result, more than \$4 billion in United States Notes were brought into circulation in \$2 and \$5 denominations. \$10 and \$20 United States Notes were never circulated but were being printed by the Treasury Department when Kennedy was assassinated.
- **It appears obvious that President Kennedy knew the Federal Reserve Notes** being used as the purported legal currency were contrary to the Constitution of the United States of America. “United States Notes” were issued as an interest-free and debt-free currency backed by silver reserves in the U.S. Treasury.
- **We compared a “Federal Reserve Note”** issued from the private central bank of the United States (the Federal Reserve Bank a.k.a. Federal Reserve System), with a “United States Note” from the U.S. Treasury issued by President Kennedy’s Executive Order. They almost look alike, except one says “Federal Reserve Note” on the top while the other says “United States Note”. Also, the Federal Reserve Note has a green seal and serial number while the United States Note has a red seal and serial number.
- **President Kennedy was assassinated on November 22, 1963** and the United States Notes he had issued were immediately taken out of circulation. Federal Reserve Notes continued to serve as the legal currency of the nation.
- **According to the United States Secret Service, 99% of all U.S. paper “currency” circulating in 1999 are Federal Reserve Notes.** Kennedy knew that if the silver-backed United States Notes were widely circulated, they would have eliminated the demand for Federal Reserve Notes. This is a very simple matter of economics. The USN was backed by silver and the FRN was not backed by anything of intrinsic value.
- **Executive Order 11110 should have prevented the national debt from reaching its current level** (virtually all of the nearly \$9 trillion in federal debt has been created since 1963) if LBJ or any subsequent President were to enforce it. It would have almost

immediately given the U.S. Government the ability to repay its debt without going to the private Federal Reserve Banks and being charged interest to create new “money”.

- **Executive Order 11,110 gave the U.S.A. the ability to, once again, create its own money backed by silver and realm value worth something.**
- **Again, according to our own research,** just five months after Kennedy was assassinated, no more of the Series 1958 “Silver Certificates” were issued either, and they were subsequently removed from circulation.
- **Perhaps the assassination of JFK** was a warning to all future presidents not to interfere with the private Rothschild Federal Reserve’s control over the creation of money. It seems very apparent that President Kennedy challenged the “powers that exist behind U.S. and world finance”.
- **On November 22, 1963, JFK was shot dead in Dallas,** Texas, in extremely strange circumstances. Phyllis Hall, a nurse who was part of desperate attempts to save the life of President John F Kennedy after he was assassinated has claimed he was shot by a “mystery bullet.” There is also strong evidence involving Lyndon B. Johnson (The following USA President) in the assassination conspiracy.

This Order returned to the US Treasury, the Constitutional power to create and issue currency. The Order has never been repealed, amended, or superceded by any subsequent Executive Order and was still valid.

President Lincoln was killed for his attempt to shut down the Federal Reserve. He once said, “Corporations have been enthroned, an era of corruption will follow, and the money power of the country will endeavor to prolong its reign by working upon the prejudices of the people, until the wealth is aggregated in a few hands, and the Republic is destroyed.”

Andrew Jackson was the first US President elected by voters without the direct support of a recognized political organization. **On July 10, 1832** he vetoed the renewal of the charter for the

Bank of the United States and three years later in **1835**, declared his disdain for the international bankers, “You are a den of vipers. I intend to rout you out, and by the Eternal God I will rout you out. If the people only understood the rank injustice of our money and banking system, there would be a revolution before morning.” An unsuccessful attempt on his life soon followed his remarks.

President James Abram Garfield had previously been Chairman of the House Committee on Appropriations and was an expert on fiscal matters. He openly declared that whoever controls the supply of currency would control the business and activities of all the people. After only four months in office, President Garfield was shot at a railroad station on **July 2, 1881**.

In the 70’s and 80’s, Congressman Larry P. McDonald spearheaded efforts to expose the hidden holdings and intentions of the international money interests. His efforts ended on August 31, 1983, when he was killed when Korean Airlines 007 was “accidentally” shot down in Soviet airspace. A strange coincidence, it would seem.

Senator John Heinz and former Senator John Tower had served on powerful Senate banking and finance committees and were outspoken critics of the Federal Reserve and the Eastern Establishment. On April 4, 1991, Senator John Heinz was killed in a plane crash near Philadelphia. On the next day, April 5, 1991, former Senator John Tower was also killed in a plane crash. The coincidences seem to mount.

Attempts to just audit the Federal Reserve have continued to meet with failure. It is virtually impossible to muster support for any issue that has the benefit of a media blackout.
