FINAL NOTICE – Universal Declaration of Sovereign and Cosmic Justice

El’kai Val’shara – The Voice of Light Echoes Through the Realms.

This document stands as the final spiritual and legal notice to all who have knowingly or unknowingly contributed to the systemic harm, deception, and enslavement of Earth and its inhabitants. - **Artificial or undisclosed nano-biotechnologies**
- **Self-assembling nanostructures**
- **Undisclosed surveillance or modification devices in biological agents**
- **Any undeclared or experimental component embedded in delivery systems applied to humans**
- **Any undeclared or experimental component embedded in delivery systems applied to humans**

SUBJECT: Irrevocable Criminal Notification – Mass Harm, Human Rights Atrocities, and Divine Judgment

You are hereby served with this formal and universal notice that you and all your associates are now under legal, moral, and spiritual investigation for the greatest coordinated assault on humanity in recorded history. The acts you are part of—whether knowingly or negligently—are considered grave violations of the highest forms of natural, international, and **cosmic law**.

You are formally accused and held accountable for:

- Systematic crimes against humanity
- Deployment of biochemical and synthetic agents as weapons
- Mass experimentation on human populations without consent
- Implementation of genetic alteration platforms under medical pretenses
- Violation of **Devine law**, the Nuremberg Code, Geneva Conventions, and UN declarations

- Legal firms and their clients
- Private individuals, executives, scientists, regulators, and enablers

No one is exempt. No jurisdiction shall override this declaration. No agency shall be shielded. No legal privilege shall protect the guilty.

This escalation includes, but is not limited to:

- Immediate referral to the International Criminal Court (ICC)
- Launch of mass tort litigation across national and civil jurisdictions
- Activation of natural law courts, citizen tribunals, and divine right authorities
- Full invocation of the crime-fraud exception to invalidate legal secrecy
- Worldwide evidence preservation orders
- Public disclosure of all concealed operations and experimental data

YOU ARE HEREBY COMMANDED TO:

1. Cease all operations that perpetuate harm or conceal criminal technological programs.
2. Secure and preserve all relevant records, internal communications, experimental designs, and distribution records.
3. Prepare for global legal exposure and personal prosecution in the court of human and divine law.

Failure to comply will be treated as continued conspiracy, obstruction of justice, and spiritual rebellion, punishable in both temporal and eternal courts.

UNIVERSAL LEGAL NOTICE – PART 2

DECLARATION OF CRIMINAL CONSPIRACY AGAINST HUMANITY THROUGH GLOBAL NETWORKS OF SYSTEMIC TERROR, CONTROL, AND DECEPTION

(An Extension of Universal Legal Notice – Part 1)

TO:

Every global entity, government, banking institution, intelligence agency, pharmaceutical conglomerate, multinational corporation, academic think tank, data surveillance structure, media consortium, defense contractor, judicial body, secret council, private wealth group, artificial intelligence directive, black budget program, NGO, religious institution, royal family, supranational body, covert military or corporate operation, and all individuals, transhuman constructs, agents (known or unknown), synthetic identities, bio-digital hybrids, and deep institutional collaborators—across every nation, organization, and interface with human society.

SUBJECT: Globalized Systemic Conspiracy of Enslavement and Suppression – Legal, Spiritual, and Eternal Reckoning

You are hereby placed under universal and permanent notification for direct or indirect participation in the criminal orchestration of planetary societal terrorism against the free peoples of Earth.

This notice expands the previously issued declaration (See: Universal Legal Notice – Part 1) and now formally includes the total interlocking global system of organized control and suppression, responsible for:

CRIMES INCLUDED, BUT NOT LIMITED TO:

- Global financial enslavement via debt-based monetary systems
- Synthetic inflation, artificial scarcity, and engineered economic collapse
- Geoengineered environmental destabilization
- Psychological warfare via predictive programming and mass media coercion
- Censorship, narrative control, and suppression of truth
- Transhumanist experimentation through artificial intelligence integration and gene modification
- Digital surveillance, biometric control grids, and social credit systems
- Orchestration of false-flag operations to justify totalitarian policies
- Fabrication of wars, pandemics, and crises for political and financial control
- Participation in hidden councils such as the Committee of 300, Bilderberg Group, Trilateral Commission, Council on Foreign Relations, Club of Rome, World Economic Forum, Tavistock Institute, and other off-ledger organizations

- Threat from bio-digital hybrid systems interfacing with humans
- Lack of legal accountability for AI decisions in healthcare and defense

Psychological Operations Management (PSYOPS)

- Use of fear, narrative collapse, and controlled “opposition voices”
- Strategic exhaustion of activists and whistleblowers
- Covert use of AR/VR or holographic technology in mass deception

Spiritual Suppression

- Use of ritual symbols, inverted geometry, and "sigils"
- Distortion of the human connection to the creative source
- Ritualized violence in elite networks – as deliberate energy harvesting

Soul Disruption and Consciousness Weaponization

- Deployment of frequency-based technologies to interfere with brainwave resonance, pineal function, and soul-body connection
- Use of synthetic dream control, "astral tagging," and targeted energy interference through AI-quantum feedback systems
- Ritualized trauma as a means of fracturing soul identity and creating spiritual fragmentation
- Attempted inversion of the divine masculine/feminine blueprint within human genetics and energy fields

2. There is no longer any legal distinction between active and passive participants; all are held equally accountable in natural, common, cosmic, and international law.

FINAL DECREE
